Northern States Power Company, a Minnesota corporation, and Great River Energy, a Minnesota Cooperative Corporation, hereby submit the enclosed Supplement to their Application to the Minnesota Public Utilities Commission for Certificates of Need for Three 345 kV Transmission Line Projects with Associated System Connections ("Supplement").

The Supplement provides all of the information required by the Commission's decision on October 30, 2007 for the Application to be accepted as substantially complete. Specifically, the Supplement contains the following information:

- Consumption and customer data for Wisconsin Public Power, Inc.;
- Customer data for Central Minnesota Municipal Power Agency;
- Explanatory information regarding what is shown on the service area map (Appendix D-3);
- A discussion of the types of utilities serving customers (in Minnesota);
- Forecasted capacity requirements associated with the forecasted energy amounts given in Appendix C-7; and


